BOD members fully attended 05 BOD meetings in the first 6 months of the year; the Head of the Supervisory Board and heads of several specialized departments were invited to attend these BOD meetings.

3. Supervisory activities of the BOD over the Board of General Directors:

In the first 6 months of 2026, the Board of Directors performed regular, close, and comprehensive supervision over the Board of General Directors in managing production and business activities and implementing the Resolutions of the General Meeting of Shareholders, specifically:

- Supervising the implementation of production and business plan targets: The BOD directed and supervised the Board of General Directors to flexibly manage core sectors (minerals, livestock breeding, animal feed) to maintain stable growth in the context of no longer consolidating revenue from Lao - Viet International Port Joint Stock Company; ensuring that the consolidated revenue results for the first 6 months of the year met the set schedule.
- Supervising the implementation of the Deep Restructuring Plan: The BOD closely supervised the Board of General Directors in collaborating with the consulting unit (Thanks Brand and Management Joint Stock Company) to collect data, survey systems, and review financial and human resource status; ensuring the progress of building the Comprehensive Restructuring Plan for the 2026–2030 period to report to the Provincial People's Committee on time in August 2026.
- Supervising financial risk management and capital flow: Frequently inspecting financial management and urging the recovery of bad debts at member units; supervising cash flow regulation options for short-term financial investments to prioritize balancing equity for key projects and optimizing financial revenue.
- Supervising project investment progress: Inspecting and urging the Board of General Directors and specialized departments to accelerate the completion of legal procedures, planning, and environmental impact assessment (EIA) for strategic projects (Vung Ang Logistics Center, Ports No. 5 and 6, Cam Lac Pig Farming Project).
- Supervising compliance with the law: Ensuring that the Board of General Directors and the executive management team strictly comply with the Law on Enterprises, the Corporation's Charter, regulations on information disclosure on the stock market, and guiding documents from the owner's representative agency (Ha Tinh Provincial People's Committee, Department of Finance).
